Development in the Watershed

The city of Sun Prairie recently lifted a moratorium on new development resulting in a flood of applications for new developments. Four of these developments are in the Token Creek watershed:

Stak Investments is developing 39 acres just east of Bird Street and south of Egge Road. A tributary of Token Creek flows through the proposed development.

Windsor Bristol Investments is developing 200 acres of land between Egge Road and the northern edge of Sun Prairie, approximately where Broadway Drive presently dead ends. This is a low-density conservation development designed to minimize run-off and maximize infiltration. A conservation easement and possible trail system is planned for the riparian zone along Token Creek, which forms the western of the proposed development.

The third development is located on the Tuschen Property, which consists of 61 acres at the SW corner of Highway 19 and County C. Storm water will enter the tributary of Token Creek that flows north of and parallel to Highway 19 and enters the creek downstream of the old mill pond dam.

The fourth development in the watershed is called Gehrke's Knoll. It is located north of Highway 19 across from Wyndham Hills. The tributary that carries water from the Tuschen Property will also carry Gehrke's Knoll stormwater, or it will flow north into Token Creek through Wynbrooke.

All of the developers, town, city, and county staff are acutely aware of the presence and importance of the Token Creek Watershed, as well as the fact that the Watershed Association is watching the development process. We are confident the municipalities and developers involved in planning these developments have the hydrological and ecological health of Token Creek in mind. The Token Creek Watershed Association must be vigilant to assure plans are appropriately implemented.

What's happening at Token Creek?

Status Report from Ken Johnson, WDNR

If you've grown impatient with the Corp of Engineer's (COE) and their implementation schedule for the Token Creek Restoration, you're not alone. Last July, after almost a year with little progress or communication from the COE, the project was assigned a new manager who summarily announced that project start-up would be postponed for over a year. Early fall of 2003 we began exploring alternative funding mechanisms for the project. Our conclusion was that while we may have to rely on several different funding sources, there are enough alternative federal and state programs to allow us to begin the project this year without the COE as the lead. Last December and January I appeared before the Town of Windsor Board and suggested that we move forward with a "phased" approach that would begin construction this year. The proposed concept is simple-instead of completing the project in one construction season we would move forward with the project in 4 or 5 phases. The amount of available funds and site conditions will determine how quickly we move through phases. The Town Board accepted the concept and voted that the Token Creek Restoration Project move ahead with this approach with the DNR acting as the lead agency. Further, if COE funding becomes available in the future we would welcome them back into the project as the lead agency.

Currently we are finalizing some of the design details, but we hope to begin re-meandering the channel this year. Keep in mind that our "phases" will expand or contract based upon funding. We are confident that we will be successful with our funding effort but it may take time. The first phase of the project is as follows:

Phase One: Breach of dam and connection to the existing channel.

The dam breach will be established through the old embankment about 200 feet southeast of the current dam. This configuration will require construction of 400 feet of channel- 250 feet below the dam and 150 feet into the reservoir. Phase One excavation will require the removal of about 1100 yards of material. This phase will begin initial de-watering of reservoir and sediment. We also anticipate breaching the dikes that separate Token Creek from the Culver Springs.

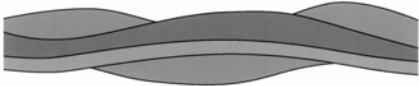
